2. Domestic Violence Initiatives Article - State of Michigan

Susan Capparelli, Executive Director, St.Croix Valley Restorative Justice Programs (SCVRJP), brought to the subcommittee's attention an article emphasizing Domestic Violence awareness. The article discussed evidence-based responses regarding Domestic Violence in the State of Michigan. Mark Lemke, Supervisor of Probation/Parole, suggested the subcommittee start mapping out a strategic plan to determine the best course of action to respond to Domestic Violence issues.

3. St. Croix County Domestic Violence Needs Assessment - Next Steps

Discussion was held on the next steps for this subcommittee. It was determined that a half-day strategic planning meeting will be scheduled in September or October. The focus of this meeting will be to determine a budget, and to discuss stakeholder issues with respect to suggested changes to our current system. Once we receive the final report from the Center for Court Innovation (CCI) this meeting will be scheduled and at that time we can work on a systems map for Domestic Violence issues.
